SUCH REPORTABLE INTERESTS MAY INCLUDE:

- HAVING A FINANCIAL INTEREST IN A BUSINESS, NONPROFIT ORGANIZATION OR PROJECT THAT ADDRESSES ISSUES RELATED TO FREE THE SLAVES' MISSION;
- SERVING AS A BOARD MEMBER OF AN ORGANIZATION WORKING ON ISSUES RELATED TO MODERN DAY SLAVERY;
- SUPERVISING A RELATIVE AND/OR DETERMINING HIS OR HER PROMOTIONS OR PAY;
- ENGAGING IN A ROMANTIC RELATIONSHIP WITH ANOTHER EMPLOYEE WITH WHOM HE OR SHE IS IN A SUPERVISORY OR REPORTING RELATIONSHIP.

FREE THE SLAVES MAINTAINS A CONFLICT OF INTEREST POLICY THAT MUST BE OBSERVED BY STAFF AND BOARD MEMBERS. SHOULD A BOARD OR STAFF MEMBER REPORT A POTENTIAL CONFLICT OF INTEREST, THE MATTER WILL BE REFERRED TO THE BOARD CHAIR AND EXECUTIVE DIRECTOR FOR INVESTIGATION AND ACTION. DEPENDING ON THE FACTS OF THE CASE, ONE OF THE FOLLOWING ACTIONS MAY RESULT:
